This proposed Gate Pa land reclassification from recreation reserve to historic reserve and the resultant proposed lease to Maori interests should be of concern all Tauranga citizens in fact to everyone. The main issue is that it looks like there has been some sort of loose 'understanding' reached in 1999 between Council and maori interests to provide land for an historic and cultural centre. I believe it is fair to say, few if any TCC residents and ratepayers were aware of this cosy little deal and certainly not that it might relate to the ex-Gate Pa Bowling Club land at Gate Pa some 23 years later. Until more information is available about the exact intention as to how the land will be developed what the parking situation will be, most importantly who will meet the entire cost of developing the proposed grandiose complex and also meet ongoing annual OPEX (operating costs) the proposal should be put on hold.

Any development of the land must <u>not</u> be at Council or TCC Ratepayers cost and if anything proceeds then vested maori interests must be solely responsible for the entire cost of developing the land and the construction costs of complete building complex itself relating to the site as essentially, it's for their benefit and they will control things and be the effective owners. It is understood that in late 2021 TECT indicated they would seriously look at providing funds to assist with this proposal.
