- Recommend to Council investment priorities and lead Council considerations of relevant strategic and high significance decisions.
- Provide guidance to staff on levels of service relevant to the role and scope of the committee.
- Establish and participate in relevant task forces and working groups.
- Engage in dialogue with strategic partners, such as Smart Growth partners, to ensure alignment of objectives and implementation of agreed actions.
- Confirmation of committee minutes.

Delegations to standing committees

- To make recommendations to Council outside of the delegated responsibility as agreed by Council relevant to the role and scope of the Committee.
- To make all decisions necessary to fulfil the role and scope of the Committee subject to the delegations/limitations imposed.
- To develop and consider, receive submissions on and adopt strategies, policies and plans relevant to the role and scope of the committee, except where these may only be legally adopted by Council.
- To consider, consult on, hear and make determinations on relevant strategies, policies and bylaws (including adoption of drafts), making recommendations to Council on adoption, rescinding and modification, where these must be legally adopted by Council.
- To approve relevant submissions to central government, its agencies and other bodies beyond any specific delegation to any particular committee.
- To appoint a non-voting Tangata Whenua representative to the Committee.
- Engage external parties as required.

Membership

Partners Tauranga City Council and "nga hapu me nga iwi o Tauranga Moana" representing Tangata Whenua within the Tauranga City Council rohe (boundaries).

Tangata Whenua representatives are to be those with signed hapu protocols. One of the six Tangata Whenua representatives is to be a Kaumatua. Kaumatua representation is to have the ability to be shared between two Kaumatua if required.

Background

Council is committed to establishing and monitoring appropriate links with Tangata Whenua to enable effective relationships to develop and meet a number of legislative requirements including those under the Resource Management Act 1991 and the Local Government Act.

1. Tangata Whenua are deemed to be the respective Iwi and Hapū of Tauranga Moana.
2. The Local Government Act 1974 and Local Government Act 2002 contain provisions relating to the exercise of the powers, functions and duties of the Tauranga City Council.

Principles of the partnership

The Partners:

- Recognise the Treaty of Waitangi as the founding document of Aotearoa NZ.
- Will work with respect, goodwill, honesty, trust and integrity toward the other party and celebrate cultural diversity.
- Recognise that the relationship is a mutual two-way relationship and any changes of the agreement need to involve discussions and agreement between the partners.
- Recognise the need for Tauranga City Council to work within a legislative framework.
- Recognise the independence of each partner, including:
 - (a) The tangata whenua representatives as a voice for the Māori communities;
 - (b) Recognise the independence of hapū and iwi;
 - (c) The Council as a democratic decision maker, responsible to the community as a whole.

Role and scope

- To forge an ongoing effective and meaningful partnership between the Tauranga City Council and Tangata Whenua.
- To facilitate meaningful understanding of future impacts on key issues affecting Tangata Whenua and Māori that Council can influence.

The functions and key tasks are:

- (a) To bring to the other partner's attention issues / concerns in respect of existing strategy or policy.
- (b) To exchange information of mutual interest.
- (c) To discuss new initiatives approaches and directions.
- (d) Agree agenda topics for the following three consecutive meetings.

Communication

- To educate the wider community on Tangata Whenua issues.
- To establish and maintain communication and consultation channels within the Council organisation and Tangata Whenua groups.

Monitoring

- To regularly monitor projects, policies and strategies managed or under development by Council which affect Tangata Whenua.
- To regularly monitor progress of key issues identified by Tangata Whenua through reporting of Council and the Tangata Whenua Collective (Te Rangapū Mana Whenua o Tauranga Moana).
- To monitor the on-going development and process of the Standing Committee.

Power to recommend

- To Council or any Standing Committee as it deems appropriate.
- Reports to Council.

9.1 Ngati Whakaue ki Maketu presentation

External Roana Bennett (Ngāti Whakaue ki Maketu)

Power point Presentation

Key points

- Presented the award winning Maketu Climate Change Action Plan.
- The purpose of the Maketu Climate Change was to ensure Maketu and it's community were prepared, could adapt and would be resilient to a changing climate.
- It was noted that an area which was a drain had recently been restored as a wetland.
- Acknowledged the koeke of local iwi and hapu for their strength, work and support of the

Climate Change Action Plan.

- It was noted that koiwi/bones were exposed when a cliff face in Maketu fell due to rain.
- It was noted that 40 properties were in the flood zone in Maketu and the cliff side properties had a life expectancy of approximately 30 years before they were affected by climate change.
- It was noted that Climate change impacts were irreversible with 40% of the world's population being vulnerable to climate change.
- Ngati Whakaue ki Maketu prepared a strategic plan which included five interconnecting priorities.
- A series of five iwi and community wananga were held to develop the core value for an iwi lead climate change action plan.
- The third of the five wananga included representatives from Bay of Plenty Regional Council, Western Bay of Plenty District Council, Ministry for Environment, Department of Conservation, NIWA and Tauranga City Council.
- The Maketu Climate Change Action Plan received a Supreme Planning Award at the New Zealand Planning Institute Awards held in Christchurch in early 2023.
- It was noted that the Maketu Community and local iwi worked to clean and restore the Maketu estuary.
- Raised concern about the proposed new development at Te Tumu Kaituna as it was a highly sensitive area for iwi environmentally and culturally.

In response to questions

- The final plan was an iwi lead community plan.

Discussion points raised

- It was noted that the Waiāri Stream leads into the Kaituna River which exits through the Maketu estuary.
- It was discussed that in the future, Whakaue marae may need to be moved in land due to climate change.
- It was noted that Ngati Whakaue were mindful of artificial lines of the Council boundaries and how Maketu was affected by this.

10.3 Tangata Whenua Presentations Updates

Staff Carlo Ellis, Manager: Strategic Māori Engagement

Key points

- Mr Ellis noted the traffic light system in his report. Green meant the project was steaming ahead, and moving forward, yellow meant the project was moving in the right direction and red highlights there were a few issues found with the project.
- Mr Ellis spoke to his report and highlights
- Wairoa cycleway relationship beneficial for both parties and was proceeding to plan.
- The Waimapu marae playground placement was at a halt, but Council staff had connected hapu with the right people.
- Follow-up around the gateway due to behavioural issues at Whareroa Marae and the boat ramp. This was being investigated and staff had suggested this be rectified before this summer fisherman used the boat ramp.
- Whareroa Marae emergency exit was a work in progress that was why it was highlight yellow in

- the traffic light system. A concern was raised by HukaPak that was referred to TCC legal team.
- A steady stream of 15 application's had been received for the development contributions grant, which had shown to be a great help to reduce costs for applicants.
 - The TCC Papa Kāinga advisor was engaging in combined conversations with land blocks across Tauranga Moana and have estimated a total of 200 plus homes be built. They were currently working towards creating a document to present to various entities to assist with costs of building Papa Kāinga.
 - The TCC Community and Papa Kāinga Grants were up to \$3M in total for three years. A discussion was held about extending the grants for a further three years.

In response to questions

- It was noted that the hapu was driving and informing the work on the Matapihi Community Plan.

Discussion points raised

- It was discussed whether it would be useful if staff from TCC shared the research that was undertaken for identification and preservation of archaeological sites at Te Tumu with iwi and hapu.

TANGATA WHENUA/TCC STANDING COMMITTEE**Chairman's report to meeting 16 August 2023 – Tauranga City Council Offices**

Tēnā koutou e ngā karangatanga maha

tēnā anō hoki tātou i runga i ngā tini āhuatanga o te ao hurihuri. Ki tō tātou tini mate, rātou kua wheturangihia anei te mihi, anei te tangi, anei te poroporoaki ki a koutou. Moe mai koutou ki ngā urupā o rātou mā. Ki a tātou nei ngā kanohi ora he mihi tēnei ki a tātou.

It gives me great pleasure to present my Chairman's report to this Standing Committee.

In my last report I touched briefly on the increasing use of matauranga Māori in mainstream that fill me with optimism for the future of central and local government relationships with Māori. Despite the scepticism there has been in some circles about the validity or validity of matauranga Māori (when compared to western science), there are numerous examples of the willingness to embrace that thinking and knowledge in the work being undertaken by this Council with the Rangapū.

Included in our agenda papers is a list of just some of the committees and working groups and projects that Rangapū members are actively involved in. It makes impressive reading and is also a testament to Council's willingness to embrace the additional skills and perspectives tangata whenua bring – matauranga Māori.

Matauranga Māori can be described as an indigenous knowledge system that is deeply rooted in Māori culture and encompassing a comprehensive understanding of the world, including traditional wisdom, values, practices, and spiritual beliefs that have been passed down through the generations.

At the core of matauranga Māori is the interconnectedness of all things. The Māori world view is one that perceives the world as a complex network of relationships, where people, nature (environment or taiao), and the spiritual realm are interconnected and interdependent. This perspective brings with it a deep respect for the natural environment and the need for sustainable practices. This innate sense of awareness and connection to the environment is almost always behind iwi and hapū objections and resistance to what is seen as unfettered and unsustainable development. Unfortunately this is often viewed as blanket resistance to development whereas the driver in fact is about caring for the environment and therefore sustaining the people.

I'd noted in my last report that Te Manawataki o te Papa is a great example of the use of matauranga Māori (and partnership) to inform civic development. How the use of cultural values, connections to the whenua and narratives benefit everybody.

There are numerous other examples – big and small – of working together in this way.

In my day job with the Ministry of Justice we are experiencing first hand the value of working with hapū and their application of matauranga Māori to inform the design and development of a new multi-million dollar courthouse for Tauranga Moana. The concept of *hohou te rongu* (restoration of peace, healing) and the connections between the metaphysical and physical worlds, the connections between atua and tāngata underpin the design of the new courthouse. It is accompanied with a narrative that is both practical and inspirational and supports the intention of the Ministry and the judiciary to transform the court system (the way the court operates) so that it puts the people who use the court, at the center.

At the end of June the Chief District Court Judge, senior members of the judiciary, the Secretary for Justice and senior members of the Ministry were given a presentation by hapū representatives on how *hohou te rongo* translated into physical building design and the applicability of those concepts to how the court should be seen and seen operate to put people and their whānau at the center. It was an impressive presentation and to my mind another great example of the power of the application of matauranga Māori.

So in conclusion, although I am concerned about the volume and breadth of matters tangata whenua (iwi and hapū) are having to keep across (every one of them is important), I acknowledge and mihi to the Council for continuing to reach out and provide opportunities for tangata whenua representatives to work together and to Rangapū representatives for embracing the opportunities. SUBJECT: Te Rangapu Mana Whenua o Tauranga Moana (“RMW”) Report and Update
PURPOSE: The purpose of this report is to provide the Tangata Whenua / Tauranga City Council Committee members with an update of RMW progress.

1. Tangata Whenua Representation on Council Committees

The partnership between Tauranga City Council and Te Rangapu continues to grow and develop, working together to bring about the best opportunities for Tauranga City. The relationship with tangata whenua is currently maintained through several forums, committees, and protocol agreements.

2. Workshops and Special Workshops update

Since the last TW/TCC Committee meeting held in June '23 at Ngati Whakaue Marae, Te Rangapu have come together in workshops to discuss and consider not only our local authority developments, but also central government plans and reforms. These workshops provide an opportunity for Te Rangapu to explore and develop Council concepts, procedures, policies, and projects and for tangata whenua to have input. I have provided subject areas to date.

a) Plan Change 33 – Enabling Housing Supply - Update

Heights within the Mount North area - Te Rangapu supports the Ngati Kuku and Ngai Tukairangi hapū discussion and feedback, to retain the cultural viewshafts from Hopukiore to Mauao, to retain the existing height and that the landscape and cultural values be considered for any addition height.

Heights surrounding Pukehinahina - Proposed limited height around Pukehinahina should be retained to protect the cultural values of the site. Ngai Tamarawaho position is to maintain and protect any existing viewshafts to Mauao. Te Rangapu support the Ngai

Tamarawaho hapū position, to take a terraced approach (12m, 22m, 27m) to enabling heights next to the Pukehinahina site.

b) Freshwater Management Tool and Impacts on Mauri and Mauiora – Dr K Morgan (Update)

TCC have convened an expert panel to review the development of a Freshwater Management Tool for stormwater infrastructure planning in the greater Tauranga Region.

The Tool is an adaptation of an US EPA software that does not incorporate Te Mana O Te Wai hierarchy. Dr Morgan offered discussion opportunities from tangata whenua for the inclusion of Mātauranga Māori to inform ways of identifying relevant ideas from Iwi/Hapu Management Plans, Cultural Impact Assessments, etc and found potential alignment with aspects of the Tool.

Te Rangapu have identified several options to incorporate taha Maori preferences into this model:

1. Maximising benefits from a Te Ao Māori viewpoint
2. Facilitated wānanga to evaluate the impacts on mauri
3. Te Rangapū could support these adaptations to the Tool development process or suggest modifications.

c) Sulphur Point and Marine Park Masterplan Preparation

Sulphur Point and the adjoining Marine Park are currently subject to a range of significant recreation and commercial pressures. The Marine Facilities Framework (2022) set as a priority the need for a comprehensive coordinated masterplan to identify future land use, facilities, and activities. The project team are working with the community including tangata whenua to develop a master plan that can be implemented over the next ten or more years.

There are a number of key objectives for the project however, relevant to Te Rangapu is the recognition of Tangata Whenua connection with the site and Te Awanui and to incorporate the Tauranga Moana design principles in any proposals developed and Tangata Whenua values are not compromised in further developments and given this is a vital piece of work for the city Te Rangapu wish to be engaged and informed of the project developments moving forward.

3. Electoral Campaign for Maori and Youth Voters

Given the Tauranga only local elections are planned for 2024, the members of RMW will be having discussions around a campaign strategy for Tauranga Moana Tauranga Tangata and youth voters, what type of information and positive messaging is needed, how it will be delivered, what collateral needs will be developed and certainty around timing and rollouts.

There may be some assumption that the election could happen on 20 July 2024 however, the timeline for Tauranga local elections still require government determination which is likely to be publicly announced this month.

4. Strategic Planning Refresh

A 1 and a half day planning sessions was held recently facilitated for Te Rangapū to check in with current and future strategic priorities and direction.

We needed to think about how things have changed since 2021, and look forward to considering how activities of the future (e.g. Tauranga City Council Long-Term Plan, the 2024 elections, etc) might impact on Te Rangapu strategic priorities.

It was a good time to connect as Te Rangapū and review why we exist, what we do, how things are working for us as a team, celebrating what is working well and where we feel there are issues and challenges? We discussed problem-solving priority issues to ensure we are working in the best way for us all.

Te Rangapu reviewed their vision and mission that provided focus for us as a team, thinking about the future, what we want to achieve and are we going in the right direction? Te Rangapu reviewed the existing strategic priority areas and feedback on what have we achieved? what is still work in progress? and what is still relevant?

- Strategic planning refresh.
- Mana o te Wai Statements.
- Action and Implementation Plans – public feedback.
- Elections 2024 for Tauranga City.
- Meeting with Commissioners – highlights, successes, address unsuccessful outcomes, and 2024 elections.
