### Terms of reference - Ngā Poutiriao ō Mauao

#### **Membership**

#### Members

The Joint Board is comprised of eight members being;

<ul> <li>Four representatives appointed by the Mauao Trust:</li> </ul>		Dean Flavell (Chair) (Ngāti Pukenga) Takiri Butler (Ngai Te Rangi) Antoine Coffin (Ngāti Ranginui) Josh Te Kani (Waitaha a Hei)		
• Four representatives appointed by Tauranga City Council: (these members will be appointed for a term subject to Council triennial elections)		Commissioner Shadrach Rolleston (Deputy Chair) Commissioner Bill Wasley The following staff members are appointed by the Council as the representatives of Tauranga City Council to fill the two remaining Council positions on Ngā Poutiriao ō Mauao, subject to limitations. The limitations are related to the staff being appointed as members only to fulfil the quorum requirements in the unlikely event that one or both of the commissioners are unavailable for a scheduled meeting of Ngā Poutiriao ō Mauao. The staff are named in the order of preference:		
		(i)	Alison Law, Manager Spaces and Places (first TCC representative if only one Commissioner absent).	
		(ii)	Carlo Ellis, Manager: Strategic Maori Engagement (second TCC representative if both Commissioners absent).	
Quorum		Four members; comprised of at least two members who have been appointed by the Mauao Trust and at least two members appointed by Tauranga City Council.		
Meeting frequency		The Joint Board shall meet as necessary in order to carry out its functions but it will be no less than two times per year.		
		The Joint Board will also meet with the Mauao Trust together, and with Tauranga City Council elected members, at least once per year.		

#### Scope

- The purpose of the Joint Board is to give effect to the purpose of the Mauao Trust to protect and preserve the mauri of Mauao to ensure the natural, physical and cultural integrity of Mauao is maintained. In achieving this purpose, the Board will:
  - Act in accordance with the guidance from the Mauao Trust on matters relating to mauri and tikanga of Mauao.
  - Act consistently with the principles of Te Tiriti o Waitangi/the Treaty of Waitangi (as outlined in the Tauranga City Council and Iwi/Hapu Protocols) and its statutory obligations under the Reserves Act 1977.

- Co-operate in partnership with a spirit of good faith, integrity, honesty, transparency and accountability.
- Actively work together using shared knowledge and expertise.
- Engage early on issues of known interest to either of the parties.
- Enable and support the use of te reo and tikanga Maori.
- Acknowledge that the parties' relationship is evolving.
- Have particular regard for the interests of the Tauranga community.

#### Purpose

- The functions of the Joint Board will be to:
  - Develop and review a Mauao Reserve Management Plan in accordance with the process outlined in the Memorandum of Understanding for Mauao Historic Reserve and Mauao Joint Administration Board (Ngā Poutiriao ō Mauao - The Guardians of Mauao) (the MOU).
  - Allocate funding provided to the Joint Board in accordance with the Funding Agreement in the MOU towards the implementation of projects that are in or consistent with the Mauao Reserve Management Plan and towards the day to day operation of Mauao.
  - Secure approval of the Mauao Trust to the Mauao Reserve Management Plan before the Joint Board approves the plan.
  - Ensure the contractual arrangements are being managed consistently with the policies, objectives of the Mauao Reserve Management Plan.
  - Identify, approve and oversee the implementation of projects either identified in or consistent with the objectives of the Mauao Reserve Management Plan.
  - Ensure the contractual arrangements are being managed consistently with the policies, objectives and strategies of the Joint Board and the Mauao Reserve Management Plan.
  - Provide to and/or seek advice from the Mauao Trust and Minister of Conversation on matters affecting Mauao and on achievement of the Mauao strategic objectives, in particular the Joint Board shall seek guidance from the Mauao Trust on tikanga related matters.
  - Consider and recommend to the Mauao Trust requests for concessions, leases and licences for all activities on Mauao and if the Mauao Trust approves the request, undertake the process for the issuing and administration of the concession, lease or licence for the particular activity.

#### **Meeting procedures**

- The Joint Board may regulate its own procedures, subject to:
  - The Joint Board operating on a preferred basis of consensus decision making. If this is not achieved, then resolutions may only be actioned by the Joint Board where this is agreement by a 75% majority of the members present and voting at a meeting.
  - No business shall be transacted at any meeting of the Joint Board unless at least a quorum of members (whether voting or not) is present at the meeting during the whole time at which business is transacted.

#### 3.1 Tauranga Moana Bio Security - Matire Duncan

External Tauranga Moana Bio Security – Matire Duncan

#### Power point Presentation

#### **Key Points**

- Myrtle rust poses a major threat to Aotearoa's native biodiversity and eco systems.
- Members of Tauranga Moana Biosecurity attended the Australisian Myrtle Rust Conference in Sydney, Australia in June 2023.
- The Tauranga Moana Biosecurity were focusing on activating the Myrtle Ora Surveillance, monitoring and maintenance strategy project which was led by the Maori Caucus of Tauranga Moana Biosecurity. Starting with communication and engagement which would include wananga for whanau, iwi, hapu and the wider community.
- Noted that Matire Duncan current contact for Tauranga Moana Bio Security group
- The most vulnerable native Aotearoa species include Pohutukawa, rata and manuka with Pohutukawa found to be the most infected.
- Noted the substantial increase in myrtle rust infection was in Summer of 2022-2023 including the first report of dieback associated with myrtle rust infection in Aotearoa.
- Noted myrtle rusts high risk season was during late spring to early autumn, November to May. With low risk months being June to August.

• Noted Nga Poutiriao o Mauao had discussed the myrtle rust infection on Mauao and staff were aware that it was users brushing past myrtle rust and spreading it further up the walking tracks.

#### Key points

- Mr Klinefelter spoke to his highlights in the report. Main update page 34; placemaking interpretation part of the management plan. Completed projects which included signage ahead of schedule. Phase two of summit project was completed before Matariki.
- Annual report was slightly delayed but was completed and presented to Council on June 19.

#### In response to questions

- The placemaking and way finding signage on Mauao had been vandalised three times, targeting te reo māori part of the signs. The signage was largely repaired.
- Consideration from Nga Poutiriao o Mauao for TCC staff to continue to commit to paying for repairs and release to public the knowledge of costs for repairing vandalised signs. This was also recognised as an opportunity to promote users of Mauao to become Kaitiaki o Mauao.

#### **Discussion points raised**

- Nga Poutiriao o Mauao supported the way forward with rectifying the vandalised signage on Mauao.
- Tauranga City Council to support Mauao Trust with access to shared spaces and sharing of resources. A pod was located on Pilot Bay for Mauao Trust to use but currently had no power connectivity. A discussion with Parks & Reserves team regarding old infrastructure from camp ground to possibly power the pod.

#### PURPOSE OF THE REPORT

1. The Memorandum of Understanding for Mauao Historic Reserve and the Mauao Joint Administration Board (MOU), requires Ngā Poutiriao ō Mauao to provide an annual monitoring report to Council. This report sets out information recommended to be provided by Ngā Poutiriao ō Mauao to Council in accordance with the requirements of the MOU.

#### RECOMMENDATIONS

That the Ngā Poutiriao ō Mauao:

- (a) Receives the report "Update Report".
- (b) Approves that the information included in this report will become the content of the Ngā Poutiriao ō Mauao Annual Information Report 2023/24 for presentation to Council (TCC)
- (c) Authorises staff to make any amendments to the content of this report as agreed at this meeting, prior to presentation of the Annual Report to Council

#### NGĀ POUTIRIAO Ō MAUAO

- 2. Ngā Poutiriao ō Mauao is the Joint Administration Board for the Mauao Historic Reserve, established under the MOU between the Mauao Trust and Tauranga City Council (TCC). Mauao is owned by the Mauao Trust, comprising the three iwi of Tauranga Moana; Ngāi Te Rangi, Ngāti Pukenga and Ngāti Ranginui. Mauao is jointly managed by TCC and the Mauao Trust through the establishment of Ngā Poutiriao ō Mauao. The iwi Waitaha also have a representative on Ngā Poutiriao ō Mauao in recognition of their historical connection to the maunga.
- 3. The Mauao Trustees currently include:
  - Hauata Paama Ngai Te Rangi
  - Buddy Mikaere Ngati Pukenga
  - John Ohia Ngati Pukenga
  - Matemoana McDonald Ngati Ranginui
  - Tamati Tata Ngati Ranginui
- 4. The MOU sets out the purpose, functions and structure of Ngā Poutiriao ō Mauao. Under the MOU, Ngā Poutiriao ō Mauao comprises of eight members, being four representatives appointed by the Mauao Trust and four representatives appointed by TCC. For the 2023/24 financial year, Ngā Poutiriao ō Mauao consisted of the following representatives:
  - (a) Mauao Trust Representatives:
    - Dean Flavell, Ngati Pukenga (Chairperson)
    - Takiri Butler, Ngai Te Rangi

- Antoine Coffin, Ngati Ranginui
- Josh Te Kani, Waitaha a Hei (2022)
- (b) TCC representatives:
  - Commissioner Shadrach Rolleston (Deputy Chair)
  - Commissioner Bill Wasley
- 5. In the event that one or both of the Commissioners are unavailable for a scheduled meeting, and to fulfil Ngā Poutiriao ō Mauao quorum requirements, two staff members are appointed to Ngā Poutiriao ō Mauao to act only when Commissioners are not available. These staff are; Alison Law, Manager of Spaces and Places (first TCC representative if only one Commissioner absent), and Carlo Ellis, Manager: Strategic Māori Engagement (second TCC representative if both Commissioners absent).

#### SUMMARY OF NGĀ POUTIRIAO Ō MAUAO MEETINGS 2023/24

- 6. Under the MOU, Ngā Poutiriao ō Mauao are required to meet as necessary in order to carry out its functions and shall meet no less than twice a year.
- 7. In the 2023/24 financial year, Ngā Poutiriao ō Mauao is scheduled to meet four times: 2 August 2023, 1 November 2023, 8 February 2023, 3 May 2023.

- 12. The prevailing economic context has resulted in higher than forecast construction cost inflation. This has led to a higher cost of materials and labour, which in turn has impacted the initial budget estimates for capital projects, such as those within the Placemaking and Interpretation programme.
- 13. As a consequence of the construction cost inflation, external funding of \$150,000 has been sought to fund the physical works at Awaiti. This is supplemental to the investment allocated within the 2021-31 LTP. A decision regarding this funding application is anticipated in late October.
- 14. Delivery of the projects within the Mauao Implementation Plan is ongoing. Several projects have been recently completed, and there are several more which are in progress. The recently completed projects include:
  - Installation of new wayfinding signage
  - Summit phase 2
  - Mid-track seating replacement
  - Karewa/Tuhua (base track)
  - Te Uru Karaka
  - Tangaroa
  - Stone Jetty
  - Installation of behaviour pou
  - Ecological interpretation signage
- 15. Additionally, several placemaking and interpretation projects have commenced and are being delivered in parallel, with anticipated completion in FY24 such as:
  - Karewa Hairpin
  - The sculpture for the beach near Te Kawa
  - Te Toka a Tirikawa
  - Wapatukakahu
  - Te Puna Waitapu / Waipareira Well



Figure 1: Te Ara Tūtanga (Base track) numbers over this year, compared to previous years.




Figure 2: Calibrated summit numbers over this year, compared to previous years.

#### Recent Success

- 6. The Motu-kauri track renewal is nearing completion and is expected to be finish in the first or second week of November. This renewal has focused on re-establishing the swales. These swales create a barrier to water, which is then directed to the side drains.
- 7. The vehicle track to the stockpile on the ocean side (Rangiwhakaoma) has had the wheel grooves armoured so that this area is accessible all year round.
- 8. A new Rabbit control contract has been created and is now underway which will see the rabbit population returned to low levels.
- 9. A new contract has been established for Full Circle to undertake Pest Plant Control via abseiling in areas too steep for our in-house team.
- 10. Infill planting and project planting sites have been established and the plants have been ordered.
- 11. The August/September Pest Animal Control pulse has been successfully completed.
- 12. The pre and post Pest Animal Control monitoring was successfully completed. This showed that control is successfully suppressing rats at 0%, Mice were reduced from 51.67% to 33.33%, and Invertebrates increased from 12% to 32%.




Figure 3. Pre and Post control monitoring data.

- 13. Waipatukakahu has successfully had two Pā Harakeke planted utilising Muka plants from Te Puna.
- 14. A large section of an old Pōhutukawa split out and covered a section of Te Ara Tūtanga. This was quickly and efficiently removed from the track and over 50% of the tree was able to be retained. The section that was not able to be retained/saved was cut into long sections and is being sorted on Mauao.

There is a great opportunity to have some of this carved, but this will need to happen quickly before the wood dries and becomes too hard.

#### Planned work for the upcoming period

- 15. Finished the Motu-Kauri track renewal.
- 16. Complete a track renewal on the Waikorire track before the end of December.
- 17. Undertake rock stability monitoring.

- 18. Organise monthly abseiling for the bluff sections of Mauao.
- 19. Organise Maori Wardens to be onsite during New Years.

#### Ongoing maintenance

- 20. Ongoing maintenance continues on the following aspects of the reserve:
  - Pest plant and animal control;
  - Stock and pasture management;
  - Walkway maintenance;
  - Sign and structure maintenance;

#### **PURPOSE OF THE REPORT**

1. To provide an overview of capital and operational project delivery at Mauao for Financial Year 2022/23.

#### RECOMMENDATIONS

That the Ngā Poutiriao ō Mauao:

- (a) Receives the report "Annual Report".
- (b) Authorises staff to make any amendments to the content required to ensure accurate record.

#### BACKGROUND

- 2. The Mauao Trust and Tauranga City Council have partnered to deliver the Mauao Implementation Plan 2018 – 2028. The Mauao Trust are the owners of Mauao, and Tauranga City Council is working alongside the Mauao Trust to jointly manage the reserve for everyone to enjoy. The Implementation Plan reflects a shared vision for Mauao. Funding for the implementation of Placemaking and Interpretation projects was successfully obtained through the 2021-31 Long Term Plan (LTP).
- 3. The Implementation Plan is underpinned by the principle of integrated management and is an adaptive and holistic tool which recognises the environment as complex, interconnected, and ever changing. The Implementation Plan sets out priorities for actions and provides guidance to the timing and costing of projects which are consistent with the vision to protect, conserve and enhance Mauao as a Taonga of exceptional significance.

#### SUMMARY OF 2022/23 CAPITAL DELIVERIES

- 4. Placemaking and Interpretation is identified as project F2 in the Mauao Implementation Plan. This project has multiple aspects and elements which are being delivered in parallel across the maunga.
- 5. The Placemaking and Interpretation programme of works has an extended delivery phase, with some smaller and simpler elements able to be fully completed early on, while other more complex aspects require appropriate consents from statutory authorities and input from technical specialists.
- 6. In FY23 some \$925,816 was spent on delivering Mauau Placemaking and Interpretation projects. This funding was allocated to a range of projects, including the completion of:
  - Wayfinding signage
  - Summit Phase 2
  - Mid-track seating
  - Karewa/Tuhua (base track)
  - Te Uru Karaka
  - Tangaroa
  - Stone Jetty
  - Behaviour Pou

- Ecological Interpretation Signage
- 7. The expenditure in FY23 also kicked off a number of projects which are projected to finish in FY24, including:
  - Karewa Hairpin
  - Beach near Te Kawa sculpture
  - Te Toka a Tirikawa
  - Waipatukakahu
  - Te Puna Waitapu / Waipareira Well
- 8. Additional to the above-listed physical works, some of money spent in the financial year funded development of designs for several projects, with further capital spending on the construction and delivery of the projects projected for FY24:
  - Fencing at summit
  - Awaiti
  - Lower Summit (northern landing)
  - Hukitawatawa (water tank area)

#### SUMMARY OF 2022/23 OPERATIONAL DELIVERIES

- 9. The Operational Fund allocated the Mauao for the 2022/23 financial year was \$731,970. This budget was used to deliver a range of activities and projects, including:
  - Pest control programmes. The pulsing method has proven to be effective and is used to target rat populations. This will be ongoing to protect native wildlife from predation. Rabbits are also a focal point of the pest control programme, with fumigation and shooting keeping the population low. Control of the rabbit population is important because their tunnelling activity poses significant risk to the archaeological features.
  - Restoration planting activity will continue to restore Te Korowai o Mauao. Native grasses and plants will be installed at strategic locations to improve habitats provide resilience to erosion. In addition, exotic species will be identified for removal. Focus will be given to large trees which pose risks to archaeological or heritage features.
  - Myrtle rust monitoring and mitigation will ramp up to quickly identify any infected specimens and limit the spread of the pathogens. It is possible that larger areas of infection may be removed or remediated by arboriculture specialists to protect native growth and reduce further spread and contamination.
  - Regular monitoring of rockfall hazards will continue in order to maintain visitor safety within the reserve. Identified hazards may be mitigated by specialists as required to reduce risk of injury.
  - Regular maintenance and management of the walking tracks to keep them safe and in good working order throughout the year and mitigate the impact of the high volume of visitors.

#### **UPCOMING CAPITAL PROJECTS**

- 10. The delivery of capital projects at Mauao will continue as set out in the Implementation Plan. A review of budget allocations and assessment of project costs will be undertaken to ensure that the Implementation Plan is delivered successfully.
- 11. There area number of capital projects within the placemaking and interpretation programme on the horizon, including:
  - Nga Kuri a Tarawhata
  - Hukitawatawa (water tower area) construction

- Tomokanga (waikorire) design
- Rangiwhakamoa Tomokanga and Punga design

#### **UPCOMING OPERATIONAL PROJECTS**

- 12. Continuous maintenance and management of Mauao programmes of work are in place to ensure that the reserve is safe, accessible, and able to be enjoyed by visitors. Planned work for the upcoming financial year includes:
  - Removal of the current health and safety risk at Te Kuia Rock/North Rock
  - Identification of exotic trees for removal, with particular consideration given to those which are on, or are threatening, archaeological or heritage sites
  - Creation of a plan to source varieties of harakeke for future planting at Waipatukakahu
  - Renewal of a section of Te Ara Tūtanga (base track) in order to manage degradation from high levels of use
  - Maintenance to signage and structures in order to maximise the operational life of newly installed assets
  - Pest plant and animal control programmes to protect and enhance the natural environment on Mauao and mitigate negative impacts from non-native species
  - Further archaeological work to determine additional areas for exploration and examination to better understand settlement patterns and sites of significance on the maunga
